ENROLLMENT FEE and TUITION. Enrollment fees are non-refundable annual fees for each child enrolled, and are due upon signing this form for initial enrollment of each child. Enrollment fees will be charged annually for re-enrollment (September 1) each year. Today, I am paying \$_____ in enrollment fees, and by signing below, I agree that I understand these fees are non-refundable, whether or not my child actually attends Teays Valley Child Development Center.

All tuition fees are due on or before your child’s first scheduled day of attendance each week. For example, if your child attends two (2) days per week on Tuesday and Thursday, his/her tuition fees will be due on or before Tuesday of each week. If payment is not received in the current week of services, a late fee of \$20 will be added to your account. Tuition rates are subject to change with a minimum thirty (30) days notice.

A one (1) week written notice is required when withdrawing your child from our center. In lieu of proper notice, one (1) week’s tuition will be due at time of withdrawal.

ABSENCE COUPONS. Absence coupons are issued for the enrollment term and are allotted according to the number of attendance days based on your weekly commitment. This will be accounted for by turning in an absence coupon to cover the missed day. All missed days beyond your coupon allotment are subject to regular tuition fees. Late enrollments will receive a pro-rated number of coupons.

I understand and agree that delinquent payment relinquishes Teays Valley Child Development Center's responsibility to provide their services, and my child will not remain enrolled at Teays Valley Child Development Center if payment is not received on time. This is a twelve (12) month contract.
